



Supply Chain Transparency Disclosures

Mirion Technologies does not use, support or condone slavery or human trafficking in any of its operations. Mirion Technologies, however, believes that the complex and specialized nature of its products and the types of countries where its limited suppliers are located, considerably lowers or eliminates the potential for slavery or human trafficking in its supply chain. Mirion Technologies also believes that its suppliers are in the best position to address this important issue. The following disclosures are made pursuant to the California Supply Chain Transparency Act, and other similar disclosure obligations of other jurisdictions. The disclosure requirements and Mirion Technologies' responses are set forth below. Whether, and to what extent, Mirion Technologies:

- a. **Reviews its product supply chains to evaluate and address risks of slavery or human trafficking, and whether verification, if any, is conducted by a third party:** Mirion Technologies does not use, support, or condone slavery or human trafficking. Mirion Technologies does not knowingly conduct business with individuals, organizations, or companies that use, support, or condone slavery or human trafficking. Mirion Technologies does not verify product supply chains to evaluate and address risks of slavery or human trafficking.
- b. **Conducts suppliers audits to evaluate supplier compliance with company standards regarding slavery or human trafficking in supply chains, and whether audits, if any, are independent and unannounced:** Mirion Technologies does not use, support, or condone slavery or human trafficking. Mirion Technologies does not knowingly conduct business with individuals, organizations, or companies that that use, support, or condone slavery or human trafficking. Mirion Technologies does not conduct audits of its suppliers to evaluate and address risks of slavery or human trafficking.
- c. **Requires direct suppliers to certify that materials incorporated into Mirion Technologies products comply with the laws addressing slavery or human trafficking in the country or countries in which they are doing business:** Mirion Technologies does not use, support, or condone slavery or human trafficking. Mirion Technologies does not knowingly conduct business with individuals, organizations or companies that use, support, or condone slavery or human trafficking. Mirion Technologies does not require direct suppliers to certify that materials incorporated into its products comply with the laws regarding slavery and human trafficking of the country or countries in which they are doing business.
- d. **Maintains accountability standards and procedures for Mirion Technologies employees or contractors that do not meet company standards regarding slavery or human trafficking:** Mirion Technologies does not use, support, or condone slavery or human trafficking. Mirion Technologies does not knowingly conduct business with individuals, organizations, or companies that use, support, or slavery or human trafficking. Mirion Technologies does not maintain internal



- accountability standards and procedures for employees or contractors failing to meet company standards regarding slavery and trafficking.
- e. **Provides company employees and management with direct responsibility for supply chain management training on slavery or human trafficking, including with respect to mitigating risks in supply chains:** Mirion Technologies does not use, support, or condone slavery or human trafficking. Mirion Technologies does not knowingly conduct business with individuals, organizations, or companies that use, support, or condone slavery or human trafficking. Mirion Technologies does not provide training on slavery or human trafficking to its employees and management with direct responsibility for supply chain management.
